# Spring 2013 Summary of Code of Student Conduct Violations and Sanctions

## **One Judicial Point:**

- One student received one point for unauthorized entry in to a construction area.
- One student received one point for failure to comply with Campus Safety when asked to leave an area.
- One student received one point for urinating in public outside.

### Two Judicial Points:

- Two students received two points each after they were arrested for underage possession of alcohol in the Village of Clinton.
- One student received two points for unauthorized entry to a dining hall after hours.
- One student received two points for possession of drug paraphernalia.
- Two students received two points each for underage possession of alcohol.
- Two students received two points each for hosting a disruptive party and failure to comply when asked to lower the volume of the music.
- Two students received two points each for violation of the College's smoking policy.

### Three Judicial Points:

- One student received three points for possession of an unlit candle.
- One student received three points for throwing an item on the ice at a Hamilton hockey game.
- One student received three points for attempting to manipulate the housing lottery.
- Two students received three points each for engaging in sexual activity in a public place.
- Two students received two points each for attempting to re-enter a building during an active fire alarm.

#### Four Judicial Points:

- One student was assigned four points for stealing a blanket from another student's room.
- One student was assigned four points for burning a candle in their room.
- One student received four points for theft of an item from the College Book Store.
- Twelve students were assigned four points each for possession/use of marijuana.
- Five students received four points each for underage possession of alcohol and disruptive conduct.

## Five Judicial Points:

- Two students received five points each for possession of multiple pieces of college furniture in their residence hall room.
- Four students were assigned five points each for a second offense of possession/use of marijuana.
- One student was assigned five points for unauthorized entry in to a locked building and failure to comply with Campus Safety.

### Six Judicial Points:

- One student was assigned six points for forging a signature on a College document.
- One student was assigned six points after entering into another student's room and urinated on floor.
- Two officers of a private society were assigned six points each after their organization was found responsible for hazing.

## Seven Judicial Points:

- One student was assigned seven points for failure to comply with campus safety; preventing the officer from performing their duties and taunted an officer.
- Two students were assigned seven points each for stealing an item from another student's off-campus apartment.
- One student was assigned seven points for igniting a firework inside of a residence hall.

## Ten Judicial Points:

- One student was suspended for one semester after a third incident of possession/use of marijuana.
- One student was suspended for two semesters after accumulating ten points during three separate incidents involving theft, failure to comply with Campus safety and unauthorized entry in to a campus facility.
- One student was suspended for two semesters after facilitating a drug deal between a student and an area non-student.
- One student was suspended for two semesters for use of a drug other than marijuana.
- One student was expelled for engaging in disruptive behavior, actions that threatened the safety of others and physical violence toward Hamilton College staff members.
